

PHOTODUPLICATION SERVICE

1. Please fill out and sign the attached form for all photoduplication requests. If you are requesting copies of manuscript or archival material, please also fill out and sign the attached "Access" form.
2. The Library reserves the right to refuse to copy any item, if such copying will either damage the material or impinge on copyright or other restrictions.
3. Some materials, primarily fragile or tightly bound books, may require copying on a special "face-up" photocopier. In such cases, to be determined by Special Collections staff, the charge for this service will be 50¢ per page.
4. In general, copies of entire books, manuscript collections, or archival record groups are not made.
5. Sheet music published after 1922 may be copied solely for research purposes and not for classroom or performance purposes.
6. No copies will be made without a completed, signed form.
7. Manuscripts and archival documents to be copied must be left in their original folder and box. Flags will be provided for identifying materials to be copied.
8. Orders of more than \$5.00 that will be mailed or picked up by the patron require a deposit. **COPIES MUST BE PICKED UP WITHIN 3 (THREE) MONTHS OF THE REQUEST DATE OR THEY WILL BE DISCARDED.**
9. Photocopy orders may not be filled the same day ordered, depending on staff availability. When the order is filled, the copies can be mailed or picked up by the patron. All orders must be placed before 4:30 p.m. (7:30 p.m. on Thursday evenings).

Publication Permission

1. The copyright law of the United States (Title 17, U.S. Code) governs the making of reproductions of copyrighted material. Under certain conditions specified in the law, libraries and archives are authorized to furnish a photocopy or other reproduction. One of these specified conditions is that the reproduction is not to be "used for any purpose other than private study, scholarship, or research." If a researcher makes a request for, or later uses, a photocopy or reproduction for purposes in excess of "fair use," that researcher may be liable for copyright infringement.
2. We define publication as any visual representation or reproduction of materials from our holdings. Instances of publication may include, but are not limited to, printed materials, motion picture films or videos, websites, and display in a commercial establishment.
3. Permission to publish materials must be requested in writing, on the appropriate form provided by this department. The application should specify what the materials are and where they will be published. Please address letters of request to the Rare Book Librarian, Curator of Manuscripts, or Archivist, as appropriate.
4. Our staff cannot sign agreement or permission forms from the publisher or user of our materials. Permission to publish, if granted, must be based solely on the terms specified in this form, or in other documents supplied by this department.
5. The Johns Hopkins University does not claim reproduction rights to the materials in its collections, and it is expressly agreed that the researcher will obtain any necessary permission to publish from copyright owners and others.
6. The Library does not grant exclusive publication rights, but reserves the right to make its collections available for use and publication by anyone who makes an application.
7. No charge is made for scholarly publication of materials, but a fee for commercial publication, which varies according to the nature and extent of use, is required. The fee schedule is available upon request.
8. When permission is granted, appropriate credit for the material used must be given as stated in the letter of permission.
